Mayor of the City of Boston :

SIR, — The officers in charge of the Law Department respectfully submit the following report of the business of the Department for the year ending January 31, 1901.

The business and duties of the Department, both in variety and amount, continue to steadily increase in the ordinary work of the Department. The legislation increasing the tax and debt limits, the abolition of grade crossings, the laying out or widening of the large and important avenues, — Columbia road, Bennington street, Commonwealth avenue, Huntington avenue, Brighton avenue, North Harvard street, and others, — and the taking of land for drainage of surface water, and the great number of petitions for damages for land taken or injured by these improvements have added greatly to the number of petitions and the regular Department work.

The Department congratulates the City on the settlement, in October, 1900, of the suit of the City of Boston against the Commonwealth of Massachusetts to recover

the value of that portion of the City's water-works which was taken for the Metropolitan Water District in January, 1898. This case was settled for \$12,531,000, which was, as near as could be ascertained, the cost of that part of the system, the idea being that if the newly-constructed parts of the water-works of the Metropolitan District went in at cost, it was fair that that portion of the system which was constructed by the City should also go in at cost. The amount of money involved in this case was probably larger than in any case ever before the courts of Massachusetts.

Mr. John T. Wheelwright, after serving as assistant solicitor to our great satisfaction since March 16, 1896, resigned the office in September of last year, and Mr. Arthur L. Spring was appointed in his stead, September 15, 1900.
